**BALTIMORE CAMERA CLUB
RELEASE OF LIABILITY AND HOLD HARMLESS AGREEMENT**

I understand that certain elements of the Baltimore Camera Club (the "BCC") and its programs and events that I am participating in may be physically and/or emotionally demanding. I further understand that my participation with the BCC and its programs and events is potentially hazardous and there is a risk of injury. I have made a voluntary choice to participate in these activities despite the risks that they present. I understand that participation in the BCC and any of its programs and events is, at all times, my choice.

In consideration of being permitted to participate in the BCC or any of its programs and events, **I agree to ASSUME ANY AND ALL RISKS OF INJURY, DEATH OR DAMAGE TO PROPERTY** which may be associated with or a result of my participation in the BCC, its programs or events.

I further agree to forever **RELEASE FROM LIABILITY AND TO INDEMNIFY AND HOLD HARMLESS** the BCC and its members, officers, directors, employees or agents, or anyone or anything else connected with the BCC or any of its programs or events for any damage, injury or death to myself or to any person or property, whether caused by negligence or for any other reason.

I agree to engage in the BCC and any of its programs or events in a reasonable fashion, and not to act negligently or engage in misconduct while participating in those activities. I understand that I will be responsible for any damages that arise out of my negligence or misconduct.

The validity, interpretation and performance of this Agreement shall be governed by and construed in accordance with the substantive law of the State of Maryland, without giving effect to conflict of law principles.

I, the undersigned, have carefully read and understand this Agreement and all its terms. I understand that this is a **RELEASE OF LIABILITY**, which will legally prevent me or any other person from filing suit or making any other legal claim for damages in the event of any injury or death to me. I nevertheless enter into this agreement freely and voluntarily and agree that it is binding upon my heirs, assigns, legal representatives and me.
